# The Inner Temple


## Welcome!



Many of our Qualifying Sessions will be held in the new training and lecture spaces here. We very much hope you will take every possible advantage of the Inn and its resources.

The Inner Temple offers a balanced and considered Qualifying Sessions programme of In Person and Online training. There is no minimum requirement for attending Inner Temple Qualifying Sessions In Person.

However, we strongly encourage you to attend as many educational and social events as you can at the Inn. There is no digital equivalent to the opportunities afforded by spending time with our members in their professional home. Many of our trainers are volunteers from our membership. They give up their evenings and weekends to spend time getting to know the newest members of the Inn and offer them help and advice in their careers.


The nearest underground stations are Temple and Blackfriars stations on the Circle and District lines.

Access for pedestrians after 8.30pm on weekdays and all weekend is via Tudor Street only.

Vehicles enter via Tudor Street Gate at all times. Exit for vehicles is via Tudor Street Gate or the Embankment Monday to Friday 6.00am to 8.30pm and at all other times is only via Tudor Street Gate.

There is no parking available on weekdays before 6.30pm and parking afterwards is only for those going to buildings within Inner Temple

# Introduction to Qualifying Sessions

## What are Qualifying Sessions?

Qualifying Sessions are a part of the requirement for Call to the Bar.

They form a vital part of a student's journey in training to become a barrister. The links made with the profession through the Inns and the Qualifying Session programme provide students with a foundation for pupillage and work-based learning but also for a career at the Bar thereafter.

## Qualifying Session Requirements

Before the date of your Call to the Bar ceremony, you must have completed a **minimum** of:

### 10 Qualifying Session points in total

#### 1 in each of the 5 themes below

1. Ethics, Standards and Values;
2. Advocacy Skills;
3. Legal Knowledge, Justice and the Rule of Law;
4. Equality, Diversity and Inclusion;
5. Preparation for Pupillage, Career Development and Wellbeing.

#### 2 Advanced Preparation and Interactive

Any session in the above themes may also include an Advanced Preparation and Interactive element. This will be advertised at the point of booking and in our emails

### Further information

- You may attend more than 10 points worth of sessions total.
- Some Qualifying Session events may award more than 1 Qualifying point and/or theme. This will be clearly advertised at the point of booking.
- Qualifying Sessions are valid for a period of 5 years after attendance.
- Bar Course students at providers outside of London may complete up to five Qualifying Sessions locally. This does not include Student Advocacy Weekends.
- **Inner Temple have no minimum requirement for attendance at Qualifying Session in person.**

Please note, it is a student's responsibility to ensure that they attend the required number and type of Qualifying Sessions.



## How to Book

Inner Temple Qualifying Sessions are booked via our website at [www.innertemple.org.uk](http://www.innertemple.org.uk).

To make a booking through our website you will need to first login to the Members Area and navigate to the Events page, as highlighted below.



Booking for Qualifying Sessions opens before the start of each term. Student Members will be notified by email when they are available to book. Events are booked on a first come, first served basis.

## Dress Codes

- the sessions are a professional commitment and a place to network with peers & senior members.

# Attendance at Qualifying Sessions

---

Please note that our events are led by senior members of the profession who have volunteered their time to educate and help members entering the profession.

As a mark of respect to our volunteers, we ask that you arrive on time and to prepare for each session as directed.

We ask that you treat all your booked Qualifying Sessions as a professional commitment.

## Our Attendance Policy

Our attendance policy applies to both in person and online Qualifying Session events.

**If you are late** for a Qualifying Session, you may still attend, if it is not disruptive to other attendees.

However, you will not be awarded the QS point for attending. Cut-off points for lateness are a matter of staff discretion.

**If you are delayed** for any reason, please contact the event manager to advise them. They can confirm if the delay would result in you not being awarded a QS point for the session.

**Please note: If you are late or not in attendance due to circumstances outside of your control, you will not be awarded the QS point for the event and you will not be refunded for the ticket cost.**

Taking the following steps to prepare can help to avoid disappointment:

- Check the travel time/public transport updates/parking/WiFi connection/equipment in advance.
- Thoroughly read the emails sent to you ahead of the event and make sure you have completed any preparation and arrive ready to participate.
- Test your camera and microphone before joining digital calls (unless it is a webinar invitation)

### You will not be awarded a QS point for attending an event if:

- You arrive late, leave early or do not participate fully in the session as directed. Attendance includes any Q&A sessions after talks and panels. Please note start and end times of the sessions will be clearly advertised at the point of booking.
- You are party to disruptive or unreasonable behaviour that affects trainers, staff or other student members during a Qualifying Session. Please see our [volunteers and participant's code](#) for further clarification on this.

Any decision made by the relevant event manager as to whether a QS point will be awarded is final.

Those who have not attended or cancelled will receive an email reminding them of their missed booking and asking them to be more considerate in booking/attending events in the future.

## Focus for the Term

These themes will guide the content of our sessions where appropriate as the academic year progresses.

## Advanced Preparation & Interactive

- You will be sent the preparation by email a week in advance unless advised otherwise.
- The preparation will usually take approximately an hour in total, except for Student Advocacy Weekends, which may take longer.
- Full participation in the session is expected. Non-participation may result in the QS point for the session not being awarded.

# Student Advocacy Weekends

---

## What are Student Advocacy Weekends?

The Inn runs three Student Advocacy Weekends a year on niche aspects of the law. These weekends are typically held residentially at venues across the UK, with locations accessible to both London and Circuit Students.

We are pleased to report that we are once again planning to hold all three weekends in person over the course of the 2025-2026 academic year.

At present, the dates and locations for this year's residential weekends are scheduled as below.

---

CIM Business Centre, Moor Hall 5-7 December 2025

Crewe Hall 30 January – 1 February 2026

Inner Temple 8-10 May 2026

(NB the Inner Temple weekend is also residential and we will expect students to stay in a hotel we book for them, as this is much easier than commuting in)

**The topics for the weekends will be published with the ballot information in October.**

---

## Further Information

These weekends are intended to be free ranging and stimulating and to provoke discussion both in formal sessions and less formal settings. Students will be joined by experts in the area under discussion and senior members of the judiciary and Bar. The [Chatham House Rule](#) applies. In addition to talks and discussion sessions, you will take part in practical advocacy sessions. Each weekend costs £85.00 and counts as 4 Qualifying Sessions. The Qualifying Session framework themes covered will be advertised nearer the time.

## How to Book

You cannot book these sessions directly via the website. Places are limited and will be allocated by a ballot system once a year. An email will be sent to student members for the current year on **Friday 10 October** with a link to the online ballot form. The ballot will close at 1pm on Monday 20 October.

Please note, submitting a ballot form will not guarantee a place on a weekend. You will be informed if you have been allocated a place in the week after the deadline.



# Student Financial Support

---

## QS Grant Scheme

The Inn heavily subsidises the cost of its educational provision to ensure sessions are accessible and affordable. However we understand that many students will find themselves under financial pressure and unexpected financial hardship may make it difficult to acquire the correct number of Qualifying Sessions.

To this end, the Inn will provide a flat rate of **£100** for students who meet the requirements – this sum is calculated on the basis that it should allow students to book the minimum number of QS required to gain 10 points (NB this does **not** include the fees for residential advocacy weekends, as these have their own bursary scheme which is opened to students if and when they are allocated a place on a weekend.)

Please note that this sum of £100 will be paid **in one go** once approved and the responsibility remains on the student to ensure they are circumspect in booking and attending Qualifying Sessions. Additional grant funds will not be allocated unless in exceptional circumstances – if you book and cancel a number of sessions at short notice or fail to attend sessions you have booked, the Inn cannot provide more money to cover the shortfall in QS points.

Requirements for the QS grant scheme are as follows:

- Applicants **must** be currently enrolled full- or part-time on a Bar Course at an Authorised Education and Training Organisation. Grants can be provided to students who start in Autumn 2025 or January 2026.
- Applicants will need to demonstrate a shortfall between their income and expenditure which cannot be fulfilled another way
- Applicants can only apply for and be awarded a grant **once** unless extenuating circumstances can be demonstrated
- Applicants should demonstrate that they have exhausted other available sources of funding including student loans and provider hardship funds.

Please note, Transferring Legal Professionals are not eligible for this scheme.

Details on how to apply for the QS Grant Scheme will be advertised on our website and in our emails before the start of Michaelmas term.

## QS Travel Subsidies

There is also a Travel Subsidy available for students studying the Bar Course at an out of London provider. This subsidy is intended to help with the cost of attending in person Qualifying Session and Student Society events in London.

Details on how to apply will be circulated with event booking details each term.

Please note applications should be submitted after your bookings for Qualifying Session events are made.

## Student Society Travel Subsidies

The Student Society Travel Subsidy Scheme is intended to assist students studying the Bar Course outside of London/the South Eastern Circuit with travel costs to events hosted by Inner Temple Student Societies in-person at the Inn. ## Marshall Hall Trust

Please note that additional financial assistance can be sought, if necessary, via the Marshall Hall Trust. The object of the Trust is to give assistance by way of loan or grant to members of the Inner Temple who are in need. The Trust is intended to cover costs for members who, through no fault of their own, e.g. loss of a parent or financial support being withdrawn, would not otherwise be able to complete the course or their pupillage.

# Student Support Schemes

---

## Marshalling Scheme

The Marshalling Scheme affords student members of the Inn the opportunity to spend up to a week sitting with a judge in England or Wales. Over the course of the placement the judge will show you the case papers and will discuss case proceedings with you. The experience will provide you with a unique opportunity to observe the workings of the court from an entirely different perspective. The scheme is open to student members who are currently on the Bar Training Course or have completed the course but are yet to obtain pupillage. Due to the number of placements available, it is only possible to marshal once via the scheme.

## Mentoring Scheme

All mentors are practitioners of at least three years' experience, who will be on hand to offer advice and general guidance to allocated students as they take their first steps to a career at the Bar.

**A link to an online survey to apply for the scheme will be sent to your email address in October 2025.**

Information required to complete the form will include personal details, geographical location and practice area interest so do ensure the information is correct as this will be used to place mentees.

Due to the high demand for the scheme, we have a limited number of places available.

## Mock Interview Scheme

The Mock Interview Scheme aims to help students build up confidence in preparation for imminent pupillage interviews. Members are given the opportunity to practise their interview technique in front of an established barrister.

**In the first instance, if you have been allocated a mentor, you should try to arrange a mock interview either with or via them. If this is not possible, the Education & Training team will try to match you with a volunteer.**

Interviews can be conducted online or in person. Interviewers and interviewees should consult together when deciding upon an appropriate interview format.

The scheme is open to Student Members who have a pupillage interview scheduled.

Some useful information on applying to be called to the Bar:

- There are 4 Call ceremonies held each year:

Ceremony Name	Ceremony Month	Ceremony Venue
Hilary	March	Treasury Building
Trinity	July	Temple Church
Deferred Trinity	October	Temple Church
Michaelmas	November	Temple Church

All ceremonies are followed by a celebratory reception for you and your guests.

- Guidance on how to apply to be called to the Bar through the online application portal will be sent out to all current Bar course students in spring 2026.
- If you intend to be called to the Bar at the Hilary ceremony in March 2026, you may have already received the application guidelines via email in spring 2025. Alternatively, please go to the '[Call to the Bar](#)' section of the website.
- To be eligible to be called to the Bar each student member must meet the following pre-Call requirements:
  - Be certified as having successfully completed the Bar course or Bar Transfer Test (for Transferring Legal Professionals only),
  - Obtained the requisite number of Qualifying Session (QS) points, and
  - Undergone the necessary fit and proper person checks (including criminal record checks). The Inn will not be able to accept any DBS checks previously obtained as the criminal record check must be obtained through the provider selected by all 4 Inns of court.
- You must complete all the above requirements two weeks prior to your chosen Call date.
- Please note that you can apply via the online application portal before you have completed the Bar course/Bar Transfer Test, before attending all necessary QS and before obtaining your criminal record check.
- You will also need to be interviewed by a Master of the Bench and have them agree to propose your Call to the Bar prior to applying. Further information about this process will be included in the guidelines due to be sent out early next year. We will assign a Master of the Bench if you do not know one personally.
- Student members are expected to attend the Call to the Bar ceremony in person.
